Bartosz Krużewski, Clifford Chance (Warsaw)

Bartosz Krużewski is an advocate, a partner at the Warsaw office of Clifford Chance and the head of the litigation practice in Warsaw and Continental Europe. He is one of the leading lawyers in Poland specializing in international arbitration, both commercial and based on investment treaties. Bartosz regularly handles disputes related to construction, infrastructure, post-M&A matters and in the energy sector. Bartosz was the chairman of the Arbitration Commission of the ICC Poland and a member of the management board of the ICC Poland. He currently serves as an alternate member of the ICC Court of Arbitration representing Poland, and is a sought after arbitrator in cases conducted before institutional and ad hoc tribunals.



Cosmin Vasile, ZRVP, Romania (IBA Arbitration Committee)

Dr. Cosmin Vasile is a Romanian lawyer and arbitrator based in Bucharest. He is managing partner of Zamfirescu Racoți Vasile & Partners and head of the firm's Arbitration Department, with practice experience of 22 years as counsel and 13 years as an arbitrator. He boasts an outstanding track-record of more than 100 international arbitration proceedings as counsel and arbitrator, providing legal counsel to both government institutions and private companies in multimillion-value disputes held under the auspices of numerous arbitral bodies or rules. Cosmin publishes and lectures regularly on arbitration related matters and is one of the initiators of the Bucharest Arbitration Days conference series.



Dr. Eglė Zemlytė, Miliauskas, Zemlytė ir Lauraitytė (Vilnius)

Dr. Eglė Zemlytė is an arbitrator and a senior lecturer at the Private Law Department of the Law Faculty of Vilnius University. She teaches international commercial arbitration and civil procedure law. Additionally, she is admitted to the bar of the Republic of Lithuania and has practiced as counsel in arbitration and litigation cases for almost 20 years. As of 2020, she is a founding partner of the boutique law firm 'Miliauskas, Zemlytė and Lauraitytė.' Since 2017, she has primarily focused her career on arbitration, regularly serving as an arbitrator or chairing arbitrations, mostly under the rules of the VCCA.
